VOLUNTEERING IN SLOVENIA REGULATION AND SUPPORT



THE SLOVENIAN LAW ON VOLUNTEERING (SINCE 2011)

This law determines volunteering and its meaning, basic principles of volunteering, conditions for performing organized volunteering, rights and obligations of volunteers and voluntary organizations and the role of the state, self-governing local communities, voluntary and non-profit organizations working in the field of volunteering in monitoring and promoting and developing organized volunteering.

NATIONAL STRATEGY FOR THE DEVELOPMENT OF NGOS AND VOLUNTEERING

The Government defines the Strategy for the Development of Non-Governmental Organizations and Volunteering and sets out measures that will contribute to NGOs and voluntary organizations as one of key building blocks of civil society, contribute to the implementation of the principles of pluralism and democracy in society.
